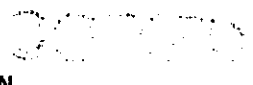

*** DETAILS OF INFORMATION ***

S-1 (ERVIN) AND S-2 (CHIME) WERE IN ROOM 340 WITH S-3 (UNKNOWN) WHO WAS THERE TO BUY THE BELOW PROPERTY FROM S-1 (ERVIN). AFTER DISCUSSING THE DEAL, S-3 (UNKNOWN) PULLED A CHROME SEMI-AUTOMATIC HANDGUN (POSSIBLY A 9MM) AND A BLACK LONG BARREL REVOLVER (POSSIBLY A .357). S-3 (UNKNOWN) THEN FORCED S-2 (CHIME) TO SECURE S-1 (ERVIN) WITH DUCT TAPE. S-3 (UNKNOWN) THEN TAPED UP S-2 (CHIME). S-3 (UNKNOWN) STRUCK S-1 (ERVIN) SEVERAL TIMES ON THE HEAD WITH ONE OF THE WEAPONS. S-3 (UNKNOWN) THEN LEFT WITH CASH FROM S-1 (ERVIN) AND THE VIDEO EQUIPMENT.

S-1 (ERVIN) STATED THAT HE WAS INTRODUCED TO S-3 (UNKNOWN) BY ANOTHER BLACK MALE SUBJECT HE KNOWS ONLY AS AL. S-3 (UNKNOWN) LEFT IN V-1 AND THE SUBJECT (AL) AND ANOTHER UNKNOWN BLACK MALE SUBJECT LEFT IN V-2.

2L3B WAS NOTIFIED. THE CRIME SCENE SEARCH UNIT RESPONDED AND DET. KEEL TOOK STATEMENTS. S-1 (ERVIN) AND S-2 (CHIME) REFUSED MEDICAL. A BROADCAST WAS MADE.
